PRIMARY: Pas de Basques; Pas de Basques & Highcuts; Highland Fling; Sword Dance.

BEGINNERS and NOVICE: Highland Fling (**Trophy Dance**); Sword Dance; Seann Triubhas; Scottish Lilt; Flora McDonald;

INTERMEDIATE: Swords; Barracks Johnnie; Hornpipe
Title: Highland Fling (5 steps); Seann Triubhas (3x1); Lilt (4)

RESTRICTED PREMIER: (Restricted to those who have not been placed 1st, 2nd, or 3rd in a Championship in the previous 4 years)

Restricted Premier dancers will dance in the Premier Sections, but a Restricted Prize will be awarded to the highest placed Restricted dancer who does not come in the main placings. Please indicate on the entry form if you are a Restricted Premier dancer.

PREMIER: Village Maid; Barracks Johnnie; Hornpipe,
Title: Highland Fling (5 steps); Seann Triubhas (3x1); Blue Bonnets (4)

PRIZES: Pre Premier: medals for sections, trophies for Titles and Trophy Dances.
Premier: Cash prizes for sections and Titles.

STEPS (unless otherwise stated)

Highland Fling, Barracks Johnnie, Lilt, Flora, Blue Bonnets, Hornpipe, – 4 steps,
Swords – 2&1, Seann Triubhas – 3&1

Competition Rules:

1. Competitor must be currently registered with their State or Regional Committee and quote their registration number when entering competition and present registration card at competition. Prizes cannot be received until card sighted. Collection of prize/s after competition will be subject to payment of postage.
2. Any complaint made by an individual against the organization or adjudication of an event must be in writing, giving the complainant's full name and address, and shall be lodged with the Organiser, if possible on the day of the event, certainly not later than 48 hours after the event. Such complaint to be accompanied by a fee of \$5.00 which is refundable if protest upheld.
3. Judges' decision is final.
4. The NDAAI reserves the right to make alterations and additions.
5. Age of competitor to be taken as at date of competition.
6. No refunds unless 'No Dance' declared.
7. Any competitor who has been taught or advised by the Judges during the 3 months prior to the competition shall not be eligible to compete.
8. Competitors must be fully dressed in complete costume, either Highland Dress or National costume including pumps, and wearing their competitive number for the presentation of prizes.
9. Video equipment is not permitted at this competition without the permission of the adjudicator.
10. Fill ins for Reel. If a competitor fails to fill in unless for a medical reason the organiser has the right to enforce SOBHD Rule which reads: "Provided due prominence is given to the fact in the programme or in a brochure by the Organiser, then during the course of a competition the comportment of the competitors may come under the jurisdiction of the judges, not only whilst dancing, but also when entering and leaving the platform and whilst waiting for the dance to start. Any unseemly behaviour on the part of a competitor or any misdemeanour likely to upset the decorum of the proceedings may be penalized by the Judges and could lead to disqualification, but a full report of any such misconduct on the part of a competitor must be submitted by the judges to the Organiser."
11. Competition conducted under the Rules and Regulations of the SOBHD/ABHDI.
Any rules pertaining to competition released by the SOBHD or ABHDI from time of printing this syllabus to the date of competition will be adhered to.
